Campaigning

Fairer Funding for Enfield — for public health services, our local NHS hospitals, our 47 primary care GP surgeries, schools and our council's wide range of essential services — has been a consistent and priority campaigning issue for our Forum down the years.

Five years ago, we launched a cross-party petition which secured the support of 10,000 fellow citizens. This past year we launched the Enfield Declaration for Fairer Funding, endorsed by some 60 local community leaders.

Our decision to focus particular attention on the scandal of low funding for Public Health Enfield has been more than vindicated since the coronavirus outbreak hit the borough in March 2020. Few people will have known until now that Public Health England was the public body responsible for monitoring and controlling infectious diseases, such as the coronavirus.

Yet both Public Health England and its offshoot here in Enfield have been the victims of cuts in government grants year by year since 2013, when responsibility for public health was transferred to local authorities under the widely discredited 2012 Health & Social Care Act.

Nationwide, the per head government grant allocation for public health has declined 23.5% since 2014- and Enfield's share has been so reduced that we decided to confront the responsible Ministers.

More than 100 Forum members and supporters each sent a personal letter to the then Minister for Public Health, Seema Kennedy, questioning why Enfield's allocation was so far below the London per head average.

Joan Ryan, the then Member of Parliament for Enfield North, followed this up by securing a televised Westminster Hall debate, attended by a strong Forum deputation, but which failed to produce a satisfactory Ministerial rep[y from a badly briefed Ms Kennedy, who is no longer a Minister or an MP.

Subsequently, a new Minister for Public Health, Jo Churchill MP, was appointed in July 2019. Ms Ryan again wrote to her pressing Enfield's case which drew an interesting reply. Ms Churchill says the government wanted to see "local government funding to be decided in a fair, robust and evidenced-based way, reflecting the most up-to-date evidence of councils' relative needs." Indeed, that is all we ask and intend to pursue during the coming year.

Following the December 2019 General Election, and the Cabinet reshuffle in February 2020, Bambos Charalambous, the Member of Parliament for Enfield Southgate, sent our case for fairer funding to the Prime Minister, the Chancellor of the Exchequer, the Secretaries of State for Health and Social Care; Housing, Communities and Local Government; the Chief Secretary of the Treasury and to the chief executive of NHS England.

The subsequent Covid-19 'lockdown' and the accompanying social guidance instructions preventing gatherings of more than two people, has delayed us pursuing this matter. But we place on record in this Annual Report our case for fairer funding together with our thanks to the signatories representing key community leaders in Enfield. It is our intention to resume the campaign once normal life resumes.

Meanwhile, this is the case we presented to Ministers:

The Enfield Declaration for Fairer Funding

We prominent and proud citizens living or working in the vibrant and diverse communities in the London Borough of Enfield, wish to draw the attention of the Prime Minister, the Secretaries of State for Health & Social Care and for Housing, Communities & Local Government, the Chief Secretary to the Treasury and the Chief Executive of NHS England to the grossly unfair and continuous under-funding of our Borough by successive governments and their statutory services.

We do so following the frank government admission that the Public Health funding baseline used by Ministers is "historic" and has been unchanged since 2013.

Since it does not take absolute levels of need into account and updated evidence — based data is excluded, it means that Enfield is perpetually underfunded and persistent, but remediable, health inequalities, between us and our linked North Central London boroughs continue.

For example: Compared with our £48 per head for Enfield's growing population, the average public health grant for 2019/20 across all London boroughs is £73 per head, despite Ministers in 2015 telling Enfield MPs that we were then 13.6% under-funded.

Why has Enfield's public health grant been cut by £446,000 this year to £48 per head, while Islington receives £104 per head, Camden £99, Haringey, on our doorstep, gets £70 and Kensington & Chelsea £130?

From 2020, the long-awaited spending review will hopefully reflect government policy — as communicated by Ministers in the present government to the Enfield Over 50s Forum — that local authority funding will in future "be decided in a fair, robust and evidence-based way, reflecting the most up-to-date evidence on council's relative needs and resources."

Having been subject to spending cuts since 2010 of some £180 million, our council services face pressures as never before.

So now is the time to make our voices heard. We are declaring loud and clear that Enfield needs a fair funding deal from government.

Community leaders from across the Borough of Enfield have come together to support the above Declaration for Fairer Funding, initiated by our Forum. It is a multifaith, cross-party and non-party call for help to the Government and NHS England from people in the 9th most deprived borough in London. Baroness Tyler of Enfield, Chair of the Enfield Poverty and Inequality Commission (EPIC) heads the list of the signatories held on the Forum's website.

EPIC Report

The final report of the independent Enfield Poverty and Inequality Commission (**EPIC**) was issued in December 2019. Forum President, Monty Meth was one of the 11 members of the Commission, chaired by Baroness Tyler of Enfield.

Their report made many recommendations to Enfield Council aimed at helping to close the big inequality gap and improve the life chances of the many people living on low incomes in the borough.

Our contribution encouraged the Commission to signal the wide differences in healthy life expectancy between families living in the East and West of the Borough. In particular, we secured the Commission's support for the opening of a new multi-purpose integrated health and wellbeing centre on the site of the North Middlesex Hospital.

Unfortunately, and like so many other projects, the coronavirus pandemic has put this on the temporary back burner. But the Forum had secured the support of the NHS Enfield Clinical Commissioning Group for the plan before the CCG was absorbed into the massive health authority covering the five boroughs forming the North Central London CCG.

The new health centre we envisage would reduce the pressure on the A&E department at the North Middlesex Hospital. It would provide a wide range of services to the all too many deprived families in the East of the Borough.

The new integrated health centre would also include a GP surgery, specialists in mental health, advisers on diet, smoking, exercising, sexual health. It would offer an MoT to all age groups from teenagers to the elderly.

The centre will, we hope, provide the leadership and guidance to penetrate and reduce the shocking life expectancy record whereby women living in the Edmonton Green ward, for example, live for the last 28 years of their lives in poor health.

Properly staffed and adequately financed this new type multi-functional health centre could be the vehicle to break down the barriers to equalising life expectancy in Enfield, which have been talked about for years, but achieved too little.

Fusion Lifestyle

The closure of all Fusion leisure centres in the borough since the March 23rd lockdown has prevented us collecting attendance figures on the successful drives we make encouraging the Over 50s population to take advantage of the magnificent facilities offered, together with the substantial discounts we have negotiated for Forum members.

However, we can report that additional fitness classes have been introduced at the Albany and Southbury centres, including chair yoga and the new soca-dance routine.

There is also a new cardio-dance workout that helps to tune the main muscles of the body.

There is no doubt that when we return to normality the Forum and Fusion will have a job to do in getting people back into being active - swimming, using the gym,

attending the many classes - after a long period in self-isolation.

Fusion was all ready to launch a new 30 and 60 minute free walks programme from the leisure centres and linked to the Over 50s days when coronavirus intervened. But they are ready to go with a

band of volunteer helpers when normal business resumes.

We wish to place on record our thanks to Dominic Hall and Gareth Heard for their continued cooperation with the Forum and in particular for their sponsoring a second annual Fun(d) Day in October at the Southbury centre which raised £785 for the Forum.

Advice Service

More than 500 people attended our confidential Monday morning advice sessions at the Dugdale Centre - a Forum initiative open to all residents in the Borough who prefer receiving personal face-to-face advice rather than trying to get answers on the phone or on-line.

More than 4,000 people have come to see our team of advisers since the project opened in 2011 and we expect the economic fall-out from the coronavirus outbreak to increase the demand for help during the coming year.

We have been very fortunate that our Forum volunteers, Kathleen Young and Rita Clayton, have been supervising this vital service for the best part of the last eight years, meeting and welcoming all enquirers.

We also record our thanks to Suzanne March for her volunteer work on the reception desk, which was compelled to close before the financial year ended and will not open for at least two months into the 2020/21 financial year.

Unfortunately, the funding crisis affecting all sections of the voluntary sector threatens to affect the continued attendance of Gillian McNally, from Citizens Advice. Although Gillian saw no less than 277 people at the Dugdale Centre between April 2019 and early March 2020, we have been told her services may have to be withdrawn later in the year.

Just how important this advice service is can be judged by the 142 people who asked to see a solicitor and the 89 people seeking tax and financial advice. We also offered help on screening for hearing tests, opportunities to chat to the police and a pre-winter energy saving check.

Our advice service is largely utilised by older, vulnerable people many of them living alone. They know they can get free, confidential help from people they can trust, and it will be a great pity if, at a time of increased hardship following the coronavirus pandemic, we have to withdraw the service for lack of funding.

Fuel Poverty

Concerned by the consistent number of excess winter deaths among older people in Enfield as a result of cold-related illnesses, the Forum has for many years co-operated with the charity National Energy Action, seeking to ensure homes are safe and warm and energy efficient.

With more than 15,600 households in the borough classified as being in fuel poverty, with family income too low to afford to both heat and eat; the Forum this year teamed up in October 2019 with HEET (Home Energy Efficiency Training) a non-profit charity.

The coronavirus lockdown has prevented us collecting final figures of their work in the borough. but we know that by the end of December they had visited 17 households saving them an estimated $\pounds6737$ a year.

The savings were based on reduced energy usage and on income improvements, usually through switching to a cheaper energy and/or water tariff, but also informing people of eligibility for the Warm Home Discount or benefits entitlement.

HEET also calculated a total carbon saving (based on reduced energy consumption) of some 7557 kg a year. They also carried out a range of work including:

- heating repairs for two households
- draught proofing 14 doors and 13 windows
- fitting radiator reflector panels to 33 radiators
- advising 12 households of cheaper energy tariffs
- supplying 91 low energy bulbs.

A HEET adviser also saw 27 people at our Dugdale Advice Service, 32 people at the Fusion Fun(d) day in October and dozens at our Winter Fair in February and we hope they will return for the coming pre-winter months.

Forum Support

For some years the Forum has encouraged Over 50s groups based at the Dugdale Centre or the various leisure centres to form their own social networks, with their own organisation and leadership. We have encouraged them to affiliate to the Forum, so that we benefit from each other's activities.

In this financial year the Forum is pleased to report that the Knit & Natter group led by Liz Gilbert has donated a

magnificent £2,200 to the Forum. The Group has some 60 members meeting on either Tuesday afternoon or Wednesday morning - or both - and they have their own lunch and birthday events.

The Over 50s Fun Group based at the Southbury Leisure

Centre, led by Anna Long and Roger Biss has donated £500

to the Forum. They were taking 100 people to a now postponed five-day holiday to Bournemouth in April, which hopefully will take place in September.

Some 250 Forum members attended social events organised once again by Jacky Pearce which yielded £552 for the Forum's funds. The events included the

annual Christmas lunch bringing together 116 members - at which Jan Oliver was presented with life membership of the Forum in appreciation of her seven years' sterling work as office and development manager.

Commissioning Group for financially sponsoring our successful Winter Fair and Falls Prevention Days, attended by some 500 people.

The financial help we have received from Michael Stennett and George Ttouli has been both welcomed and appreciated for helping to sustain the heavy cost of producing and posting our Newsletter six times a year.

Health Issues

This has been a momentous year; it began with worrying signs on the horizon of a decline in the accessibility of our local health services, with indications of a tightening of the rationing regimes being introduced for hips and knees, among other things, and no improvement in Enfield's now chronic shortage of GPs, the basic building block of our NHS, and it ends with the coronavirus pandemic and lockdown at the time of writing.

The withdrawal of blood testing at 13 surgeries by the Royal Free Hospital (RFH) which was noted in last year's annual report has not been resolved, though several of us dutifully attended a series of workshops at the invitation of the Clinical Commissioning Group (CCG) to provide factual detail of the serious consequences for some categories of patient and practical suggestions on ways forward. Our thanks to the North Midd for continuing to service its stable of GP practices and for maintaining open and positive communications with us and for the heroic work it is currently facing up to.

The biggest issue and cause for concern, until the pandemic, has been the enforced merger by NHS England (NHSE) of Enfield CCG with the four other North Central London (NCL) boroughs: Barnet, Camden, Islington, Haringey and last, and almost certainly least as it is the weakest health economy in NCL Enfield

Our council acceded to this without any consultation, in the expressed hope that some of Camden and Islington's resources would come our way. So far that hope has proved vain. NHS England ruled against consultation with the patients and the public with no resistance from Enfield CCG and this the first time since Community Health Councils were established in 1974, precisely to give patients and the public a voice in the NHS, that we have been deprived of the opportunity to influence local decision makers or hold them to account. Thus nearly 50 years of active public involvement and support for the NHS has been swept aside.

Certainly, some of RFH's patients are coming our way to use the new orthopaedic facilities at Chase Farm. Undaunted, the Forum is fighting to improve the over-challenging journey many must make as the RFH failed to co-ordinate its business plan with Transport for London (TfL). The overall effect of the NCL merger of CCGs is a grave loss of any apparent possibility of local, democratic involvement in the management and roll-out of primary care and its articulation with secondary care, and this exclusion of the public, which cuts off any contribution we can make for co-design with the service, is a retrograde step. England is being divided into 44 footprints ours, NCL, has over 1.4m residents and we no longer have open pathways to providers. There will be 3 lay representatives on the NCL board, but they have been appointed with no public input and will be paid, they are not elected to represent us. Until this March 2020, we have been a constant presence at Enfield CCG's public meetings where our president, Monty Meth, submitted testing questions. We have been able to apply pressure and get answers. How we can do this with the far bigger and inaccessible 5 borough organisation remains to be fought for.

We are told that there will be an Enfield Partnership Board on which those with responsibility for the NHS in Enfield will sit in partnership with the Council. The Forum wants NCL policy decisions devolved down to facilitate local delivery of services but, so far, we have no information about who will sit on this board or how we can access its deliberations and decisions and nor do we know if the Health & Well Being Board, (on which one of the Forum's executive sits), will continue to exist or be absorbed into an NCL-wide group. To date we have not seen the constitution of this new board nor do we know its proposed membership and we intend to insist on transparency and that the public is represented and given the chance to hold it to account.

Interest by Forum members in the profile and functioning of Enfield's health services from GP practices and hospitals and mental health provision to social care and community provision has been high, and pre-dates the pandemic. The Forum has held regular meetings of its health group made up of those attending their surgery's Patient Participation Group (PPG), helping us build a borough-wide picture of what is happening and where problems are concentrated. We have been greatly assisted in this by Defend Enfield NHS providing secretarial back-up, and publicity as well as active support and information.

In addition, Medicus, an experimental partnership of 14 surgeries, has been willing to ask the Forum for its views. As a result of this, and the feedback we get from the many other groups we run and our general membership, as a grass roots organisation we are unparalleled in the spread of our understanding of health issues and have been an asset to providers who have often sought our views, so we have been disappointed that the CCG has not established the promised Patient Reference Group but enquiries about that must, obviously, wait until we emerge from this stage of the Covid19 world-wide pandemic.

Another development this year has been the introduction of Primary Care Networks (PCNs) in a move that could help to offset the shortage of GPs, give registered patients wider choice, share support staff and other resources and support single-handed practices. At the time of writing, PCNs have yet to get off the ground.

Since there have been few face to face GP appointments, no routine referrals to hospital and necessary diversion of resources to contain the spread of the ferociously clever C19, as well as the need to maintain distances, primary care has adapted to an even more stringent situation than

normal and we must hope that when we emerge from this scourge, there will be greater investment in emphasising the importance of the work of our General Practitioners and of training new GPs as well as far greater investment in hospital and the NHS and Public Health. Public Health budgets and power have been systematically slashed over the last ten years depleting our national ability for rapid local response to this pandemic. This self-defeating policy must be reversed.

Earlier in the year we lost, to the sad death before his time, John Wardell, who led Enfield CCG and was always very responsive to and highly regarded by your Forum. He is greatly missed.

At the time of writing we are weeks into lockdown and talk is turning to a lifting of restrictions. Many of our readers will be in vulnerable categories and we hope you have stayed well and safe. Over- early relaxation risks a further surge and we have yet to count the cost in lives lost in the community and in care homes which Enfield has a significant number of.

The Forum takes its lead from public health experts at London's Imperial College:

- Find cases in the community as well as in hospitals and care homes, isolate them, trace their contacts using local PH teams and digital tools
- Track the epidemic so we know the hotspots needing special attention
- Build community resilience by providing local support for the most vulnerable and those most badly impacted by the control measures
- Suppress transmission using testing, distances and hygiene and effective protective equipment
- Investigate differential effects on men, minority ethnic groups and other at-risk groups emerging as the crisis unfolds
- Ensure that the most vulnerable have simple access to a basic income to which the Forum would add food.

We shall continue to keep you informed and to do our best to represent your interests in our pursuit of a healthy older age for all.

Stay safe, keep your distances and keep well.

After many years leading the social committee, Irene Richards stepped down and we have been determined to keep things as organized as she did! Our small team has renamed itself the SET-Social Events Team, and have shared out the jobs, which is working really well.

The equally long-standing development and office manager Jan Oliver has retired from her paid role but luckily for us, jumped straight into the social side as a volunteer - aren't we lucky? We also welcome Chrissy Kontourou, who has already arranged a well-supported trip to Bulgaria as her first event.

The team has offered the members of the Forum another varied and stimulating selection of social opportunities, including Music hall, meals out supporting local restaurants both lunches and dinners, free walks in our amazing City, day trips to Coventry, Maidstone, Whitstable, Suffolk, Hammam experience, river cruises, exhibitions, mystery

Regular book club and coffee club meetings give some continuity to the social programme and a new regular lunch club will follow shortly in the same fashion.



Fundraising Report

The Over 50s Forum 200 Club started in August 2015 and is run by Jim Cantle. Since the inception of the lottery we have paid out over £11,000 to the 55 winners and we have

raised nearly £7,000 for the Forum, money which helps towards the costs of production and distribution of the newsletter. We would like to thank all those who have contributed over the years. The cost is £5.00 per month and can be paid by standing order or cheque or cash for 3 months, 6 months or a year. As many of you may know Jim is partially sighted and we would like to thank his wife Lynne and member Alvin Meisuria for their invaluable help with

In October 2019 we started a Bingo Club which usually meets once a week on a Monday afternoon at Malone & Co. in Enfield Town. This has raised nearly £600 for the Forum and has provided an enjoyable social afternoon for a regular group of members. Full details about the club can be obtained from Jim.

Forum Focus

Our newsletter Forum Focus is produced every two months, highlighting issues of importance to our members and the wider community in Enfield. It also lists the Forum Meetings, the excellent range of activities organised by our Social Events Team, as well as the activities of Forum Groups and of those groups affiliated to

the Forum.

We also have regular contributions from the local police and Enfield's Public Health team, and we give updates from Fusion, which runs the council's leisure centres and with whom we have negotiated excellent discounts for members.

With a 7,500 print run, Forum Focus is posted to all members



and distributed to all affiliates, libraries, leisure centres and to some GP surgeries. It remains a key weapon in our campaigning endeavours on a range of issues, including the consistent under funding by government of services in Enfield (our Fairer Funding campaign) and, more recently, the call for better bus services to Chase Farm Hospital, especially for those attending the new orthopaedic surgery centre there.

The production of the newsletter is overseen by our volunteer editor Yvonne Mulder along with our President Monty Meth and Secretary Tony Watts. The distribution is organised by Peter Smith, with a great group of volunteer 'stuffers' who make sure all the newsletters are put into the envelopes (already labelled and franked by other volunteers in the office).

The new design for the newsletter we introduced last year has been well-received and it has helped us attract new advertisers. Forum Focus is the most important tool we have in making our presence felt and our views known to MPs, councillors and the various statutory bodies that govern us. It helps us to retain a strong membership and a voice in the community, particularly as what remains of the local commercial press has reduced its coverage of the borough.

Forum Website Redevelopment

ver the past few months, Yvonne Mulder and Chris Chinnery have created and launched our new website. One key requirement was for the site to be pleasant to use on smartphones, iPads etc, and to work with screen reading software.

The way the old site was constructed meant that a change of style was almost impossible without starting from scratch and any adjustments relied on arcane and obsolescent software that required its own expertise.

The new site, like 35% of all the websites in the world, is based on the open source WordPress platform. This job of adding to or changing the site's content or even its appearance no longer requires technical expertise.

Our aim is to turn https://enfieldover50sforum.org.uk into the most up to date window into the activities of the Forum, particularly for the ever increasing number of silver surfers who are swelling our ranks. Already the site has a search facilty so that users can readily find the information they are looking for; annual reports and newsletters, joining and renewal forms - these in future will enable online applications, renewals and payments.

Office and Development Report

e were saddened when Jan Oliver retired in November after several years of exemplary service to our members. She has been a hard act to follow but we have been fortunate to recruit Ruth Fathaddine who has settled well into the role of managing the office and supporting members. Her first major task was to organise the Winter Fair which due to her efforts and our volunteer was an outstanding success.

With almost 6000 members maintaining our data base, ensuring that our records are in order, producing and sending our eNews. Over two thirds of our members have email addresses and this facility allows us to send out regular updates on events and happenings which affect our Jan Oliver with the Forum life age group. It also lets us help our affiliate organisations by informing this wider audience of their activities.

In managing the office Ruth is of course ably assisted by Diane Barron. We continue to recruit other volunteers to help us process subscriptions, label and prepare envelopes for posting out of our newsletters together with our regular team of 'Stuffers'. We thank them on behalf of all our members.

Universal Credit Project

he Forum-initiated two year project funded by the Council came to an end during the year. The project which provided support to over 50s claimants with limited IT skills was very successful and its success has led to it being funded for a further two years.

Over a dozen Forum members have regularly given up their time to help applicants from the job centres to manipulate the considerable IT hoops necessary in order to receive benefits while they continue to seek work. As a result of this project our team of 10 Forum volunteers has since successfully run 750 individual sessions and

by so doing helped 180 clients to prepare CVs and manage the hurdles imposed by UCS. Of the clients seen a significant number have since found acceptable positions. The project team was fortunate to be under the direction of Williamz Omope, a full-time job club advisor. Our thanks

again to our volunteers who have and continue to support claimants.

For the future Enfield Voluntary Action is the purse holder for the project and managing the project in cooperation with the Forum.

Finance

he good news is that our finances were on target for the year. Our contingency fund remains at the same £50,000 needed in the event that the Forum had to cease operating. As you will see from Appendix 2 the Forum is in good health financially and will endeavour to remain so for the foreseeable future. Thanks to the efforts of our office staff and volunteers who processed £47,489 in subscriptions income. As many members have signed a gift-aid statement we will be able to reclaim some £8,800 during the new financial year. Additional income from advertising in the newsletter, our bingo and 200 clubs plus some welcome contributions from our Knit & Natter Group, the Southbury Fun Group and Social Events Team meant that we ended the year with a £4,027 surplus. This surplus will help us weather the inevitable impact of the coronavirus lockdown.

Our thanks are also due to Stennett & Stennett and George Ttoulli for not only sponsoring the Forum but also providing free advice to members at our weekly Dugdale surgeries.

For the future our Finance Committee is considering the options for simplifying payments of subscriptions by either direct debits or via credit card payments. Members can already make payments by online banking or by standing orders. That our finances remain in such good order is due the excellent bookkeeping and diligence of our Treasurer.
